1. Proposed property bearing Survey No. 12/1A of Village Damocem, Taluka Sattari of North Goa District by Alfred Francisco Andrade.

The Committee inspected the site on 19th March 2021. The committee had decided to recommend for environmental clearance with following condition:-

Existing road from major district road till temple shall be made 6 meters wide and 6 meters wide road from the temple to the quarry to be constructed.

2. Proposed project National Blue Pearl situated in Survey No. 30/1 of village Muguli Taluka Sanguem Goa, by Alex A. Fernandes.

The Committee inspected the site on 20th March 2021. Committee had decided to recommend the EC

3. Proposed project by Shri. Abhishek U. Salgaonkar bearing Survey No. 42/0 of village Ibrampur, Pernem Taluka, North Goa District.

The committee inspected the site on 23rd March 2021 and has decided to recommend rejection of application to the SEIAA.

Reasons for Rejection:-

- i. Observed area is rich in Bio diversity which includes deciduous vegetation like teak, sal etc.
- ii. Footprints of animals such as Wild boar, Gaur etc were observed on the site near/at water body. As such the water body is used by animals.

During the inspection the members observed that there is no proper access to the proposed site quarry.
