

**Minutes of the 102nd Goa State Expert Appraisal Committee
(Goa-SEAC) meeting held on 25th February 2019 at 4.00 pm. in the Conference Room of
the 3rd floor, GTDC, Patto-Panaji, Goa.**

The hundred and second meeting of the Goa-SEAC was held on 25th February 2019 in the Conference room of the GTDC, Paryatan Bhavan, Panaji at 4.00 p.m. under the Chairmanship of Prof. Suhas Godse. The list of members who attended the meeting is at Annexure – I.

At the beginning Chairman welcomed the members and requested Secretary, SEAC to proceed as per the Agenda items (refer Annexure – 2).

1. Representative of M/s Sadekar Enviro Engineers Pvt. Ltd , Goa consultancy, Goa made the project-specific presentation on behalf of PP for project proposal seeking environmental clearance (EC) for the proposed construction of building and construction project at P.T. Sheet No.9, Chalta No. 73/12 of Cuchelim, Bardez, Goa" by **M/s Central Park c/o Cosme Costa Constructions Pvt. Ltd** . The project Proposal was discussed on the basis of presentation made and documents submitted by the proponent. All issues related to environment including air, land, soil, ecology and biodiversity and social aspects were discussed. Committee noted that the project is under **8a (B2) category of EIA Notification 2006 (building & constructions)**. Further documents like Consolidated statements, Form I and IA, project specific presentation and plans submitted are taken on the record.

However, based on inspection held on 17/11/2018 and subsequent to the project specific presentation, Committee sought compliance with regard to the following:

- A. PP should submit revised area statement with road and site plan.
 - B. Provision of second gate for emergency movement of vehicles.
 - C. PP should submit revised water balance and STP calculation.
 - D. PP should submit proposed plan for bed plantation of Banana plants.
 - E. Plan for provision for waste water released from car washing.
 - F. PP should submit plan for organic waste converter and detailed waste management plan.
 - G. Inventory on numbers of trees already cut on site.
 - H. Proposed landscape plan.
 - I. Proposed safety measures for workers during construction.
 - J. Details on proposed corporate social responsibility initiative (CSRI) proposed for the locality around project area.
2. Representative on behalf of Project Proponent made the project-specific presentation on behalf of PP for project proposal seeking application for environmental clearance (EC) for modification of the project **Ocean park Residential apartment & commercial shops** at Sy no. 249/1-A Taleigao Plateau, Dona Paula, Goa. The project Proposal was discussed on

the basis of presentation made and documents submitted by the proponent. All issues related to environment including air, land, soil, ecology and biodiversity and social aspects were discussed. Committee noted that the project is under **8a (B2) category of EIA Notification 2006 (building & constructions)**. Further documents like Consolidated statements, Form I and IA, project specific presentation and plans submitted are taken on the record. However, based on inspection held on 09/01/2019 and subsequent to the project specific presentation, Committee sought compliance with regard to the following:

- I. PP should submit detailed waste management plan.
- II. Detailed landscape plan.
- III. Details on proposed corporate social responsibility initiative (CSRI) proposed for the locality around project area.
