At the beginning Chairman welcomed the members and requested Secretary, SEAC to proceed as per the Agenda items (*refer Annexure – 2*).

1. Communication dated 29th April 2020 from **Captain of Ports, Panaji** for Proposed re-development of nine Coastal Jetties at Goa seeking clarifications regarding the number of locations personal hearing is to be carried out. The committee perused the letter and noted that this is a single project to provide navigation facilities along the waterways for the planned routes and the nine jetties will act as embarkation and disembarking stations of passengers. These jetties are meant for local passengers and tourist, besides two jetties at Pilgao and Shiroda are meant for bunkering, replenishment and repair services. No cargo is anticipated on all nine jetties as mentioned in earlier letter dated 27th May 2019 by **Captain of Ports**.

Now the Committee after detailed examination of the letter received from the Goa State Pollution Control Board including the High Court orders was of the opinion that in this case of nine jetties the project proponent is Captain of Ports a Government Department and the project is for construction of nine passenger jettiesø which are interlinked hence one public hearing to be conducted at North Goa and one at South Goa for which the venue may be decided by the respective District Magistrate and Goa State Pollution Control Boardö.

The meeting ended with a vote of thanks to the chair.
