

Minutes of the 120th Goa State Expert Appraisal Committee (Goa-SEAC) meeting held on 09th May 2020 at 10.30 am in the Conference Room of the 3rd floor, GTDC, Patto-Panaji, Goa.

The hundred and twentieth meeting of the Goa-SEAC was held on 09th May 2020 in the Conference room of the GTDC, Paryatan Bhavan, Panaji at 10.30 am under the Chairmanship of Prof. Suhas Godse. The list of members who attended the meeting is at Annexure – 1.

At the beginning Chairman welcomed the members and requested Secretary, SEAC to proceed as per the Agenda items (refer Annexure – 2).

1. Project specific presentation for construction of **New High Court complex at Penha de Franca, Porvorim, Goa** proposed by Goa State Infrastructure Development Corporations(GSIDC). The consultant M/s LKS India Pvt. Ltd presented the brief project proposal on behalf of PP before the Committee and informed that the project design won the Griha award for green building. The project also has provision for rain water harvesting, 100kv solar panels, 50 KLD sewage treatment plant. The Goa-SEAC conducted the site inspection of the proposed site on 09th May 2020. The committee after taking into consideration the relevant documents, plans submitted by the PP, detailed presentation and site inspection, sought following details from PP.
 - a) Provision for second vehicular gate to facilitate exit and ensure safety of Judges, advocates, officials, employees and clients in case of an emergency.
 - b) Installation of biogas to treat the biodegradable waste and re-use of biogas in canteen.
 - c) Recycling of treated sewage water for flushing and gardening.
 - d) Provision of storage of non biodegradable waste.
 - e) Plantation of local trees along the southern and eastern compound wall.
 - f) Installation of charging points for Evs in the judges parking as well as basement parking.

- g) PP should submit details of assembly area during emergency.
 - h) PP should submit Location of STP with maintenance details.
2. Project specific presentation by minor mineral quarry (**new laterite stone quarry**) in survey no. 39/0 village Cola, Canacona, Goa by **Mr. Domic Fernandes**. The consultant presented brief project report of the proposed laterite quarry having lease area 1.8500 ha. The proposed extraction capacity 10000Cum per annum with (1:0:3) overburden ratio having 6mt maximum depth. The committee conducted site inspection of the proposed site on 22nd February 2020.

After detailed presentation the committee decided to recommend the said proposal to Goa-SEIAA with following conditions:

- a) The members suggested to plant variety of local fruit bearing trees.
 - b) Committee directed PP to submit a letter from the owner of land stating post closure the quarry boundary will be fenced as preventive measures for any accident or to prevent fall of human and animal into the quarry.
3. Project specific presentation by minor mineral quarry (**new Basalt stone quarry**) in survey no. 12/1 village Damocem, Sattari, Goa by **Kaloshi Granites**. The consultant presented brief project report of the proposed basalt quarry having lease area 0.3576 ha. The proposed extraction capacity 24000 cum per annum. The committee conducted site inspection of the proposed site on 2nd May 2020.

After detailed presentation the committee decided to recommend the said proposal to Goa-SEIAA with following conditions:

- a) The PP should stock the topsoil near the site to be used for plantation.
- b) The PP has to submit list of trees with their botanical names.
- c) PP has to prioritize on plantation of local fruit bearing tress and retained the same trees which are at site.

The meeting ended with a vote of thanks to the chair.
