Minutes of the 49th Goa State Expert Appraisal Committee (Goa-SEAC) meeting held on 15th September 2015 at 10.30 a.m. in the Conference Room of the Goa State Pollution Control Board (GSPCB), Patto.

The Forty-ninth meeting of the Goa-SEAC was held on 15^{th} September 2015 in the Conference room of the GSPCB from 10.30 a.m. onwards under the Chairmanship of Prof. Antonio Jaime Afonso. The list of members who attended the meeting is at "*Annexure* – 1".

At the outset, Chairman welcomed the Members requested Secretary, SEAC to proceed as per the Agenda items ($\underline{refer\ Annexure-2}$). Subsequently, representative of M/s Parsvnath Developers Pvt. Ltd., Panaji, Goa was requested to make a project-specific presentation in respect of their proposal seeking prior environmental clearance (EC) for construction of commercial building – Imperium-V at Plot nos. 43, 44, EDC Patto Plaza, Panaji. Accordingly, environmental concerned engaged by the Project Proponent (PP) - M/s Sadekar Enviro Engineers Pvt. Ltd., Goa presented salient features before the Committee. However, the Committee felt that technical matters w.r.t. (a) odour-control measures, (b) energy conservation calculations, (c) water balance and effective provision for rainwater harvesting initiatives, (d) site-specific soil characteristics and hydro-geological status, (e) disaster mitigation measures visà-vis fire-fighting provisions, (f) landscape management and (g) availability of time-series data pertaining to land use / land cover and CRZ applicability, etc., were not made clear to enable environmental appraisal. As such, the Committee desired that the PP need to compile the requested data and make the presentation again, incorporating the compliance to (a) to (g) above. As such, the PP was requested to e-mail the observation-specific response at the earliest prior to re-schedule the presentation.
