

**Minutes of the 60th Goa State Expert Appraisal Committee
(Goa-SEAC) meeting held on 3rd March 2016 at 02.30 p.m. in the Conference
Room of the EIA Secretariat, Patto.**

The sixtieth meeting of the Goa-SEAC (*hereinafter termed as 'Committee'*) was held on 3rd March 2016 at 02.30 p.m. in the Conference room of the Goa State EIA Secretariat under the Chairmanship of Mr. Antonio Jaime Afonso. The list of members who attended the meeting is given in "Annexure – I".

At the beginning Chairman welcomed the Members present for attending the routine meeting scheduled on first Thursday of every month. While referring the Agenda items (Annexure – 2).

1. The compliance / clarification submitted by **M/s Shrem Aansav Realty LLP** dated 2nd December dated 21st January 2016 in response to project-specific observations following project-presentation made during 54th Goa-SEAC meeting held on 26th November 2015 were discussed / deliberated. After ascertaining / verifying the same, **the Committee has decided to consider the proposal and forward it to the Goa-SEIAA** subject to submission of (a) 'Sanad' from South Goa District Collectorate, Margao and (b) Tentative budget estimate towards CSR-related activities.
2. Following the site-inspection of Candola area in respect of proposal (2nd revised proposal) received from **M/s Gera Developers Pvt. Ltd.**, Pune for proposed development in survey no. 33/1 of Candola village in Ponda taluka as well as in response to the written representations received from Betqui-Khandola Samvardhan Samittee and ... Housing Board Association, Candola, **the Committee has decided to schedule a project-specific presentation in the next/subsequent meeting** during which clarifications to various representations to be obtained from the PP.
3. Similarly, following the site-inspection of Sancoale area in respect of proposal received from **M/s Trinitas Developers LLP**, Sancoale for proposed construction of residential-cum-commercial complex at survey no. 198 of Sancoale village in Mormugao taluka, **the Committee** has noted that the proposed construction involves total BUA more than 1,50,000 sq.mts., and mandates preparation of EIA report being categorized as 8(a) – B1 from NABET/QCI-accredited environmental consultant (*as per the 'Schedule' annexed to the EIA Notification, 2006*). Accordingly, it is **decided to deliberate the matter and**

finalize the ToRs' for issuance during next meeting (i.e. 61st) to be scheduled on 17th March 2016.

4. As regard to the request received from **M/s Mahadhan Real Estates LLP** to consider the project proposal for construction of residential-cum-commercial building proposed in survey nos. 99/1 & 2, 105/1, 2 & 3 – C3 in Taleigao village, Tiswadi taluka, **the Committee has decided to invite the project proponent (PP) for project-specific presentation during its next meeting (i.e. 61st) scheduled on 17th March 2016.**

The meeting ended with vote of thanks to the Chair.
