Minutes of the 66th Goa State Expert Appraisal Committee (Goa-SEAC) meeting held on 5th May 2016 at 10.30 a.m. in the Conference Room of the Goa State Pollution Control Board (GSPCB), Patto.

The sixty-sixth meeting of the Goa-SEAC was held on 5th May 2016 in the Conference room of the GSPCB from 10.30 a.m. onwards under the Chairmanship of Mr. Antonio Jaime Afonso. The list of members who attended the meeting is at \tilde{o} <u>Annexure – 1</u> \tilde{o} .

At the outset, Chairman welcomed the Members and informed that Dr. Mohan R. Girap ó Secretary has to proceed to Pune to attend Goa State Pollution Control Board (GSPCB)-related court matter at the National Green Tribunal (NGT), Pune. Subsequently, post-presentation discussion / deliberation w.r.t. the Terms of References (*in response to a proposal submitted by M/s Global Ispaat Ltd. Seeking ToRs' for proposed expansion in production capacity at its unit located in Cuncolim Industrial Estate*) was taken up on priority. However, the Committee desired that these ToRsø be communicated to the Project Proponent (PP) only after the submission of Government approval by the project proponent in response to a -Cabinet Decisionø w.r.t. discontinuation of any new / expansion of such plants in the State of Goa taken during 2003.

Later, post-presentation compliance (*i.e. documents / clarification*) submitted by M/s Mahadhan Real Estate LLP, Vasco-da-Gama was perused / ascertained / verified by the Committee in response to the observations deliberated during its 62nd meeting held on 5th April 2016. On scrutiny, the Committee noted that PP has submitted incomplete information / compliances and needs to submit relevant compliance to the following points -

- 1) All the technical reports submitted should be authenticated by investigation agency / consultant / subject expert.
- 2) Submit a letter regarding appropriate foundations for the structures at the site so as to transfer the load to hard stratum based on seismic considerations.

Further, Committee decided to re-inspect the site at Taleigao on 20th May 2016 to ascertain / verify provisions proposed to be adopted (a) to control / manage probability of flooding likely to be caused during heavy monsoon, especially during the construction and post-construction scenarios and (b) for storm water management.

Subsequently, post-presentation compliance submitted by M/s Gera Developments Pvt. Ltd., seeking prior environmental clearance (EC) for construction of premium housing and commercial development '*Enchanted woods*' at survey no.33/1, Candola village, Ponda, Goa

was perused for verification. However, the **Committee noted that PP has submitted** incomplete compliances and needs to submit relevant information / update to the following points -

- 1. -Soil investigation reportø submitted by the PP should be authenticated by investigation agency / consultant / subject expert.
- 2. -RWH drawing(s)ø should be authenticated by consultant prepared along with the revised structure as shown in the said drawing(s).
- 3. Responses to the *induced traffic managementø* due to the project to be submitted along with traffic movement pattern.
- 4. Details on *-*standby power requirementøto be submitted.
- 5. Hater requirementøduring construction phase should be clarified and submitted.
- 6. Copy of *Sanadøonce* issued / current status should be submitted.

The meeting ended with vote of thanks to the Chair.
