

**Minutes of the 72nd Goa State Expert Appraisal Committee
(Goa-SEAC) meeting held on 4th August 2016 at 3.00 p.m. in the Conference
Room of the Goa Coastal Zone Management Authority (GCZMA), Patto.**

The Seventy Second meeting of the Goa-SEAC was held on 4th August 2016 in the Conference room of the O/o the GCZMA from 03.00 p.m. onwards under the Chairmanship of Mr. Antonio Jaime Afonso. The list of members who attended the meeting is at “Annexure – I”.

At the outset, Chairman welcomed the Members and proceeded as per the agenda items (refer Annexure – 2). Subsequently, six-monthly compliance reports submitted by various project proponents (PPs’) were perused / discussed. Based on the deliberations in respect of the said submission, it was decided to carry out post-EC site-inspection of developmental activities for which prior environmental clearance (EC) was issued to **M/s Raj Housing Development Pvt. Ltd (Raj Enclave)** for proposed residential and commercial complex at Mapusa, Bardez taluka, **M/s Devashri Real Estates Developers, Panaji** for proposed construction of residential buildings in survey no. 361/1 (*Plot-A*), Socorro village, Bardez taluka and **M/s Milroc Good Earth Property & Developers L.L.P., Panaji** for proposed expansion of residential-cum commercial complex - “Milroc Kadamba” in survey no. 21/2-D, Baingiumim village, Tiswadi taluka in North Goa district during last week of this month.

Later, in response to new developmental proposals submitted by **M/s Umiya Holdings Pvt. Ltd.**, for proposed construction of residential complex at Sancoale, Mormugao (South Goa) and **M/s Alcon Construction LLP.**, for construction of residential building at St. Inez, Tiswadi (North Goa), the Committee decided to conduct site visits on 16th August 2016 to understand the location-specific characteristics.

The meeting ended with vote of thanks to the Chair.
