## Minutes of the 76<sup>th</sup> Goa State Expert Appraisal Committee (Goa-SEAC) meeting held on 6<sup>th</sup> October 2016 at 3.00 p.m. in the Conference Room of the Goa State Pollution Control Board (GSPCB), Patto.

The Seventy-sixth meeting of the Goa-SEAC was held on 6<sup>th</sup> October 2016 in the Conference room of the GSPCB from 03.00 p.m. onwards under the Chairmanship of Mr. Antonio Jaime Afonso. The list of members who attended the meeting is at "<u>Annexure – 1</u>".

At the outset, Chairman welcomed the Members and requested Secretary, SEAC to proceed as per the Agenda items (*refer Annexure – 2*). Subsequently two new applications received by Goa-SEAC for environment clearance from M/s DLF Limited for proposed commercial development at EDC, Patto-Panaji and M/s John distilleries Pvt. Ltd for proposed expansion of production capacity from 2.5 KLD to 5KLD of malt based distillery unit at plot no. M-21/21-A & 21-B, Cuncolim-IDC, Cuncolim, Salcete, Goa were perused. After due deliberation and discussion, the Committee decided to carry out site inspection in respect of proposal submitted by M/s DLF today and also decided to invite M/s Mahadhan Real Estate LLP, Chimbel to make project-specific presentation during next meeting scheduled on  $20^{\text{th}}$  October 2016 w.r.t. proposed residential and commercial complex with hotel.

Later, the Committee decided to conduct site-inspection on following two areas on  $25^{\text{th}}$ October 2016 –

- a. New proposal submitted by M/s John distilleries Pvt. Ltd for proposed expansion in production capacity.
- b. Post-EC monitoring visit w.r.t. a project of **M/s Prudential Limited**, **Margao** for which EC has been already issued by the Authority (*i.e. Goa-SEIAA*) during 2012.

The meeting ended with vote of thanks to the Chair.
