

**Minutes of the 77<sup>th</sup> Goa State Expert Appraisal Committee  
(Goa-SEAC) meeting held on 20<sup>th</sup> October 2016 at 10.30 a.m. in the  
conference hall of Goa-PCB, Patto.**

The Seventy-seventh meeting of the Goa-SEAC was held on 20<sup>th</sup> October 2016 in the conference room of Goa State Pollution Control Board (GSPCB) from 10.30 a.m. onwards under the Chairmanship of Prof. Antonio Jaime Afonso. The list of members who attended the meeting is at “Annexure – 1”.

At the outset, Dr. Mohan Girap, Secretary, (Goa-SEAC) conveyed his inability to participate in the discussion / deliberations owing to official commitment at BITS Pilani, Goa. Accordingly, as directed by Chairman, Mr. Purnanand Savoikar, Member, (Goa-SEAC) was nominated to perform as a ‘Secretary’. Thereafter, matters were taken up for consideration / suitable decision as per the agenda item referred in (Annexure – 2).

Subsequently, M/s Aditya Environmental Services Pvt. Ltd, Mumbai made the project-specific presentation on behalf of **M/s Mahadhan Real Estates LLP** for proposed residential cum Commercial complex with Hotel at survey no. 82/0 of village Chimbel, Tiswadi, Goa. Following the said presentation, the Committee sought compliance to following observations prior to further appraise the proposal:

- 1) Provide a detail of modalities of treatment of potable water as of now and in the long run.
- 2) Provide details of Compartmentations in building by way of smoke stop doors.
- 3) Cross section showing the slopes of each parts A, B, C and D of the plot.
- 4) Since rock is available at site, groundwater recharge option needs to be verified.

Accordingly, **the Committee decided to await the submission of compliance from the PP to above-mentioned observations prior to forwarding suitable comments to the Authority.**

The meeting ended with vote of thanks to the Chair.
