Minutes of the 97<sup>th</sup> Goa State Expert Appraisal Committee

## (Goa-SEAC) meeting held on 27<sup>th</sup> September 2018 at 3.30 p.m. in the Conference Room of the EIA Secretariat, O/o Goa State Pollution Control Board (GSPCB), Patto-Panaji.

The ninety seventh meeting of the Goa-SEAC was held on  $27^{\text{th}}$  September 2018 in the Conference room of the GSPCB at 3.30 p.m. under the Chairmanship of Prof. Suhas Godse. The list of members who attended the meeting is at õ<u>Annexure – 1</u>ö.

At the beginning Chairman welcomed the members and requested Secretary, SEAC to proceed as per the Agenda items (*refer Annexure* - 2).

Recommendation for proposed construction of Beach Resort on land bearing Sy. No. 230/2 of Anjuna Village, Bardez Taluka, North Goa District, Goa state by N.M. Bhashyam. Proposal forwarded from the Goa Coastal Zone Management Authority (GCZMA) for comments as per the guidelines laid down in hotel policy. The project Proposal was discussed on the basis of documents submitted by the proponent. All issues related to environment including air, land, soil, ecology and biodiversity and social aspects were discussed. Consolidated statements, Form I and IA project specific presentation and plans submitted are taken on the record. Goa SEAC conducted the site inspection on 28/06/2018 and directed the propjet proponent to submit detailed EIA report of the site.

After detailed presentation the committee instructed for correction in the presentation and directed the PP to present detailed presentation alongwith changes suggested by the Committee members.

- 2. With reference to the communications received from the Authority (Goa-SEIAA dated 25<sup>th</sup> September 2018 with regards to the proposal by M/s Sapna Ceramics Pvt. Ltd., proposed environmental clearance (EC) for capacity enhancement (<u>i.e. from 1,250 tons per day to 2,500 tons per day</u>) after amalgamation of three leases and one new lease. The Goa-SEIAA communicated back to Goa-SEAC to submit environmental damage report caused due to the said extraction. Accordingly the committee noted that the said extraction is as per the six monthly reports submitted by PP and the quarry was existed prior to 2006. In view of the same the Committee decided to call the project proponent for detailed presentation before the committee and raise the query with regards to amount of area envisaged for extraction during 1<sup>st</sup> phase of EC, at what depth the amount has been extracted and amount of area /trees have been cleared at the project site at 1<sup>st</sup> Phase of EC.
- 3. With reference to the communications received from the Authority (Goa-SEIAA dated 25<sup>th</sup> September 2018 with regards to proposed developmental activity in Sancoale area by M/s Umia Developers Pvt. Ltd., the authority sought a report and confirmation from

Goa-SEAC whether the construction is as per the recommendation of Goa-SEAC within 10 days. Accordingly the committee decided to conduct site inspection of the proposed site.

The meeting ended with vote of thanks to the Chair.
