Minutes of the 98th Goa State Expert Appraisal Committee (Goa-SEAC) meeting held on 15th October 2018 at 10.30 pm. in the Conference Room of the 3rd floor, DPSE, Porvorim Goa.

The ninety eighth meeting of the Goa-SEAC was held on 15^{th} October 2018 in the Conference room of the 3^{rd} floor, DPSE, Porvorim, Goa. under the Chairmanship of Prof. Suhas Godse. The list of members who attended the meeting is at õ<u>Annexure – 1</u>ö.

At the beginning Chairman welcomed the members and requested Secretary, SEAC to proceed as per the Agenda items (*refer Annexure* - 2).

1. With reference to the communications received from the Authority (Goa-SEIAA dated 25th September 2018 with regards to the proposal by M/s Sapna Ceramics Pvt. Ltd., proposed environmental clearance (EC) for capacity enhancement (<u>i.e. from 1,250 tons per day to 2,500 tons per day</u>) after amalgamation of three leases and one new lease. The Goa-SEIAA communicated back to Goa-SEAC to submit environmental damage report caused due to the said extraction. Accordingly the committee noted that the said extraction is as per the six monthly reports submitted by PP and the quarry was existed prior to 2006. In view of the same the Committee and raise the query with regards to amount of area envisaged for extraction during 1st phase of EC, at what depth the amount has been extracted and amount of area /trees have been cleared at the project site at 1st Phase of EC.

Accordingly the representative on behalf of proponent M/s Sapna Ceramics Pvt. Ltd., along with environmental consultant appeared before the committee and filed written as well as oral submissions before the Authority on the above points which was raised by the committee. The committee heard the representative appeared on behalf of project proponent and taking into consideration the documents submitted therein and after detailed discussion and deliberation decided to recommend the proposal to Goa-SEIAA for further action in the matter.

2. With reference to the communications received from the Authority (Goa-SEIAA) dated 25th Septemebr 2018 with regards to proposed developmental activity in Sancoale area by m/s Umia developers Pvt. Ltd as decided in previous meeting the committee conducted site inspection on 29th Septyemebr 2018 and directed the applicant to submuit details with respect to the change in name of project /owner of the project. Compliances with respect to waste treatment plant. Details on sewage treatment plants.

The meeting ended with vote of thanks to the Chair.
