

Agenda Items for the 11th Goa-SEIAA meeting scheduled on 27th March 2014

1. Final decision on the proposal for expansion of the existing facility for handling Propane and Butane –submitted by **M/s Ganesh Benzoplasts at Sada, Vasco.**

The proposal was last discussed during 10th Goa-SEIAA meeting held on 23rd January 2014. Subsequently, the Chairman inspected the site on 29th January based on which clarification / submission of details were sought from the Project proponent (PP) who has complied with the same vide letters dated 30th January 2014, 11th February, 2014 and 12th March 2014.

2. Consideration of the Minor Mineral Quarry proposals seeking prior Environmental Clearance (EC) in light of the recommendations by Goa-SEAC taken during its 17th meeting held on 24th February 2014 and detailed deliberations held subsequently during its 19th meeting held on 20th March 2014. Goa-SEAC while appraising the proposals has referred to the following Official Memorandums (O.M.s') / Notification(s) –

- i) O. M. No. L-11011 / 47/2011-IA.II(M) dated 18th May 2012 in compliance to the 'Order' of Hon'ble Supreme Court dated 27th February 2012 in IA no. 12-13 of 2011 in SLP (C) No. 19628-19629 of 2009 in the matter of Deepak Kumar Etc. Vs State of Haryana and ors. – mandating the requirement of prior environmental clearance (EC) for minor mineral mining projects upto less than 50 Ha. of lease area.
- ii) Draft Notification (Extraordinary) No. 1698, PART-II, Section-3, Sub-section (ii) dated 19th July 2013 – mandating the requirement of NABET / QCI accredited or MoEF notified environmental consultant for preparation and presentation of Environment Impact Assessment (EIA) report and Environment Management Plan (EMP) for a particular category of project for that sector.
- iii) Notification (Extraordinary) No. 2116, PART-II, Section-3, Sub-section (ii) dated 10th September 2013 – notifying exception of applicability of General Conditions(s) for minor mineral project or activity of less than 5 Ha. of lease area.
- iv) Notification (Extraordinary) No. 545, PART-II, Section-3, Sub-section(ii) dated 4th March 2014 – delegating the powers vested under Section(5) of the Environment (Protection) Act, 1986 (29 of 1986) to all the State and Union Territory Environment Impact Assessment Authorities (i.e. *to issue show cause notice(s) to project proponent(s) or activities within their jurisdiction and to issue directions for keeping such environmental clearance in abeyance or withdrawn from them*) for any violations of the EC condition(s).

- v) Draft Notification (Extraordinary) No. 624, PART-II, Section-3, Sub-section(ii) dated 10th March 2014 – notifying the list of State-wise villages categorizing them as Ecologically Sensitive Areas (ESAs) as well as mandating the regulatory, implementation and monitoring mechanism for various categories of projects / activities, mentioned therein.

- f. Renewal of Basalt quarry located at Sy. No. 67/1 of Ibrampur village, Pernem taluka, North Goa District (lease area - 2,600 Sq.mts) of **M/s Shalini Metals**.
- g. Renewal of Basalt quarry located at Sy. No. 32/4, 5, 6, 7 and 9 of Allorna village, Pernem taluka, North Goa District (lease area - 50,000 Sq.mts) of **M/s S. Kumar Metals**.
- h. Renewal of Basalt Stone quarry located at Sy. No. 309, Xeldem village, Quepem taluka, South Goa District (lease area - 2,700 Sq.mts : production capacity – 2,218 m³ per year) of **M/s. Mohan Sheldekar**.
- i. Renewal of Basalt quarry located at Sy. No.32/9(P) of Ibrampur village, Pernem taluka, North Goa District (lease area – 45,500 Sq.mts) of **M/s Gajanan Zarapkar**.

- j. Renewal of Basalt Stone quarry located at Sy. No. 64, Barcem village, Quepem taluka, South Goa District (lease area – 7,000 Sq.mts) of **M/s. Rosario Noronha**.
 - k. Renewal of Basalt Stone quarry located at Sy. No. Sy. No 102/0 of Barcem village, Quepem taluka in South Goa District (lease area - 10,000 Sq.mts) of **Mr. Satyandra Faldessai**.
 - l. Renewal of Basalt Stone quarry located at Sy. No. S.No S.No 105/1 of Barcem Village, Quepem Taluka South Goa District (lease area - 7,000 Sq.mts) of **Mr. Prasad Rama Naik Dessai**.
