

Agenda Items for the 22nd Goa-SEIAA meeting held on 11th May 2015

- A. Project –specific presentation by **M/s Nestle (India) Pvt. Ltd.**, Tisk, Usgaon for the proposed expansion of Industrial building situated at Plot No. 294/1, 2,3,4 and 297/0, Usgaon Industrial area, Tisk, Usgaon, Ponda, Goa. (*Site was inspected by Chairman Goa-SEIAA on 2nd March 2015*).
- B. Consideration of Goa-SEAC's recommendations (36th meeting held on 21st April 2015) for proposed construction of "Rail Freight Terminal" in survey nos. 33/1A, 33/1B, 34/1 to 34/9, 01/1(part), 4/1, 4/2(part), 3, 5, 6, 9, 10 of village- Xic – Xelvona, Quepem Taluka by **M/s Sociedade de Fomento Industrial Pvt. Ltd.**, (*The Goa-SEAC has appraised the aforesaid project proposal as "Category 'B' under 8(a) - Building/Construction projects" as per the 'Schedule' annexed to the EIA Notification, 2006*). Environmental consultant – M/s Padmaja Aerobiologist Ltd., Mumbai.
- C. Consideration of Goa-SEAC's recommendations (36th meeting held on 21st April 2015) for **renewal** of one Basalt-stone quarry lease (A) - 12/Basalt/09 (*Lease area - 5,000 sq.mts.*) and **two new** Basalt-stone quarry leases – (B) lease area - 5,000 sq.mts. and (C) lease area - 15,000 sq.mts. having gross total production capacity – 24,5000 m³ per annum located in survey no. 13/2 (part) of Cordem village (*total lease area – 2.5 Ha.*), Quepem taluka, South Goa district by **M/s Christopher Furtado**. (*The Goa-SEAC has appraised the aforesaid project proposal as "Category 'B' under 1(a) – Mining of minerals" as per the 'Schedule' annexed to the EIA Notification, 2006*). Consideration of Goa-SEAC's recommendations (35th meeting held on 16th April 2015) for the proposed development of residential complex (without Farmhouse) in survey nos. 12/1(P), 13/1-A(P), 13/1-B(P) of Panelim village, Tiswadi Taluka, North Goa district by **M/s In-Orbit Malls (India) Ltd., Mumbai**. (*The Goa-SEAC has appraised the aforesaid project proposal as "Category 'B' under 8(a) - Building/Construction projects" as per the 'Schedule' annexed to the EIA Notification, 2006*). Environmental consultant – M/s Aditya Environmental Services, Mumbai.
- E. Consideration of Goa-SEAC's recommendations (37th meeting held on 28th April 2015) for proposed construction of 'Milroc Colina' – a residential-cum-commercial development in survey no. 33/1 at Goa Velha, Tiswadi Taluka in North Goa district by **M/s Milroc Good Earth Developers, Panaji**. (*The Goa-SEAC has appraised the aforesaid project proposal as "Category 'B' under 8(a) - Building/Construction projects" as per the 'Schedule' annexed to the EIA Notification, 2006*). Environmental consultant - M/s J. M. Environet Pvt. Ltd., Rajasthan.
- F. Consideration of Goa-SEAC's recommendations (37th meeting held on 28th April 2015) for proposed expansion of institutional building in survey no.192/1, plot nos.1, 193/1, 230/1, 231/1, 232/1, 233/1, 234/1, 235/1, 235/3, 241/1, 243/1, 189/1 of plot no.2, 189/1 PART,191/1,192/2 of village Sancoale, Marmugao, South Goa by **M/s BITS Pilani, Goa Campus, Sancoale**. (*The Goa-SEAC has appraised the aforesaid project proposal as "Category 'B' under 8(a) - Building/Construction projects" as per the 'Schedule' annexed to the EIA Notification, 2006*). Environmental consultant – M/s Aditya Environmental Services, Mumbai.

G. Consideration of continuation / extension of ‘Contractual Agreement’ for Adv. Raghvendra Kalagutkar as Legal Retainer in the O/o EIA – Goa State Secretariat.

H. Decision on the following communications received from –

- a. Extension of validity of Environmental Clearance (EC) issued by the Ministry of Environment and Forests (MoEF) dated 8th May 2008 for proposed construction of commercial complex at Plot no. 35, Patto Plaza, Panaji by **M/s DLF, Campal, Panaji**. *(as per the provisions of the EIA Notification, 2006 (as amended), it is understood that the validity of EC for construction project is 05 years and may be considered for its renewal if the on-site construction activity has not been initiated as has been done in the case of setting up of CHWTSDF at Dharbandora by Goa-SEIAA during its last tenure.)*.
- b. Request for conducting the EIA through the Goa-SIDC for the 3rd Mandovi bridge at Panaji by **Mr. Srinivas Kamat, Alto-Batim**.
- c. Complaint by Mr. Francisco Xavier Carvalho, Sanguem regarding Water and Air pollution by stone crusher adjacent to Salaulim dam operated by **M/s Marushka Stone Crusher** located in survey no. 79/0 of Uguem village, Sanguem Taluka.
- d. Request for an Amendment in EC issued by the Goa-SEIAA earlier (*copy attached*) vide letter no. 3-181-2010/STE-DIR/208 dated 19th May 2011 for proposed residential-cum-commercial complex at Khorlim, Mapusa, Bardez Taluka, North Goa district by **M/s Buildmore Infrastructures India Pvt. Ltd., Panaji**. The PP intends to revise Non-FSI areas thereby changing Total BUA from 27,267.49 sq.mts. to 29,958.13 sq.mts. (*additional BUA of 2,690 sq.mts.*) with no change in occupancy, resource requirement and waste generation.
- e. Revalidation of EC issued for residential group-housing with club house and a hotel in survey no. 87/1-A-1, 1-A-2 & 1-A-3, Reis Magos village, Bardez Taluka, North Goa district by **M/s Delanco Home and Resorts Pvt. Ltd., New Delhi**. The EC has been issued by the MoEF dated 12th September 2008 for 84 villas (*lower ground + upper ground + 1st floor*), club house, 200-rooms 5-star hotel (*G + Stilt + 2 floors*). However, the proponent intends to drop “200-rooms 5-star Hotel”.
