Minutes of the 16th Goa State Environment Impact Assessment Authority (Goa-SEIAA) held on 27th November 2014 at 04.00 p.m. in the Conference room of the EIA Secretariat, O/o Goa State Pollution Control Board (GSPCB), Patto.

The sixteenth meeting of the Goa-SEIAA was held on 27^{th} November 2014 in the Conference room of the GSPCB under the Chairmanship of Dr. Pramod Pathak. The list of members is annexed (*refer Annexure – 1*).

At the outset, Chairman welcomed the Members and informed about the purpose of convening the meeting to finalize pending matter(s), if any, and to consider Goa-SEAC recommendations and finalize the decision for grant of prior environmental clearance (EC) to project proposals as listed in the agenda items (*refer Annexure – 2(a) to 2(d)*).

Accordingly and after verification of compliances submitted by respective project proponents, as a follow-up of project-specific Goa-SEAC recommendations in its 27th meeting held on 20th November 2014, the Authority decided to grant prior environmental clearance (EC) to the following proposals –

- a. Proposed Group Housing and Commercial project at Survey No. 40/0 of village Vanellim Salcete South Goa by M/s Akar Creations Pvt. Ltd.
- b. Proposed construction of residential-Cum-Commercial complex in survey No.21/2-D, Baingiunim village, Tiswadi taluka, North Goa, by **M/s Milroc Good Earth Property & Developers L.** Margao.
- c. Proposed construction of Commercial-cum-Residential complex in Survey No. 276/1 of Morombi-O- Grande village, (Chimbel), Tiswadi Taluka by **M/s Amit M. Sukhthankar**.

Further, in response to agenda item no.(3), the Authority decided to refer back the project proposal, forwarded by the O/o Goa Coastal Zone Management Authority (GCZMA), stating that build-up area (BUA) proposed in the construction of Hotel/Resort in Varca in Salcete Taluka by **M/s Shiva Goa Palaces Pvt. Ltd.,** being less than 20,000 sq.mts., does not require prior environmental clearance (EC) as mandated in the EIA Notification, 2006.
