MINUTES OF THE 38TH GOA STATE ENVIRONMENT IMPACT ASSESSMENT AUTHORITY (GOA-SEIAA) MEETING HELD ON 05TH OCTOBER 2017 AT 04.30 P.M. IN THE CONFERENCE ROOM OF THE GOA STATE POLLUTION CONTROL BOARD.

The thirty-eighth meeting of the Goa-SEIAA (*hereinafter referred as 'Authority'*) was held on 5th October 2017 at 04.30 p.m. in the conference room of GSPCB, 1st floor, Dempo Tower, Patto, Panaji. The list of members present during the meeting is annexed (*refer* <u>Annexure – 1</u>).

At the outset, Chairman welcomed Authority members and briefed about the agenda items (*refer Annexure* -2) to be taken up for discussion / deliberations and suitable decisions. Accordingly, the same were considered as detailed below -

Agenda item No. 1:-

1. <u>M/s ALCON Constructions (Goa) Ltd., Panaji</u> Revision in the outline plan in the proposed development activity (*for which EC was grated earlier by Goa-SEIAA vide no. 3/18/2010/STE-DIR/206 dated 19th May 2013 for 250-bedded hospital cum 42-room hotel*) proposed in survey no. 112/1, 112/1(P), in Taleigao village, Tiswadi taluka. During previous meeting the Authority decided to re-inspect the site. Accordingly Authority inspected the site on 27th September 2017. During inspection the Authority members noted that the project proponent has already started the construction activity for which environmental clearance (EC) has not been granted by Authority. It was decided by the Authority to issue Stop Work Order cum Show Cause Notice to the Project Proponent as per provision of section (5) of Environment (Protection) Act 1986 and to why penalty should not be levied for violation of EIA Notification 2006, Further the Authority decided to direct the project proponent to give clear picture of the total project which would come up at the proposed site in order to study the traffic management and also the discharge of storm drainage for the project in total.

Further, Authority noted that reply given by the project proponent especially regarding the discharge of storm water drainage was totally not satisfactory and not proper in nature.

Meeting concluded with a vote of thanks to the chair.
